1. NB 1. Proposed Rezoning and General Plan Alignment Project

The Proposed Rezoning and General Plan Alignment Project study session was presented by Community Development Consultant, Nancy Fong.

Commissioner McMeekin asked what "RD1250" and "RD 1500" refer to. Fong stated that it represented a previous way to list 1250 and 1500 square feet per unit. However, that is inconsistent with the general plan and there are new units of measures used today. Commissioner Flores asked when the map process will be complete. Fong stated that they hope to be done with Phase One by May or June 2025. She hopes the second phase will be done by July or August. They would like to change the language on the map from "RD 1250" to reflect the new form of measurement, which would be "HDR" or "MDR". Fong clarified that this map and Phase One shows mainly south of Badillo St. in Covina. Phase Two would include more parts of the city.
