A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COVINA, CALIFORNIA, TO AMEND THE FISCAL YEAR 2024/2025 CAPITAL IMPROVEMENT PROGRAM BUDGET AND APPROPRIATE \$251,952.93 FROM MEASURE CC FUNDS TO BE TRANSFERRED INTO THE PARKS CIP FUND FOR USE TOWARDS DEMOLITION OF EXISTING EASTERLY BUILDING AS A PART OF THE COVINA RECREATION VILLAGE PROJECT – PROJECT NO. P2202

WHEREAS, the City of Covina is a municipal corporation duly organized and existing pursuant to the Constitution and laws of the State of California ("City"); and

WHEREAS, the Fiscal Year 2025 Operating Budget & Capital Improvement Plan (CIP) was approved on June 4, 2025; and

WHEREAS, the approved Operating Budget and Capital Improvement Plan (CIP) is in accordance with all applicable ordinances of the City and all applicable statutes of the State; and

WHEREAS, the City of Covina wishes to amend the 2024/2025 Capital Improvement Program Budget and appropriate \$251,952.93 from Measure CC Funds to be transferred into the Parks CIP Fund for use towards demolition of existing easterly building as a part of the Covina Recreation Village Project – Project No. P2202.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COVINA, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:
