EXECUTIVE SUMMARY/BACKGROUND:

As part of the City's Fiscal Year 2025-2026 Capital Improvement Program, the City Council approved a project entitled, "Trash Enclosure Project – City Wide", which consists of the installation of a new trash enclosure at the northeasterly end of the Covina Police Department, adjacent to Heritage Plaza.

The installation of a new trash enclosure at the Covina Police Department will feature:

- Construction of a new trash enclosure per City of Covina Trash Enclosure Standard Plans
- Installation of metal roof panels and metal doors for sustainability
- Color match to City specific Standard Plans that complements other citywide trash enclosures

DISCUSSION:

The Department of Public Works requested informal proposals from five companies approved for On-Call Services for Maintenance and Repair of City Facilities. City staff subsequently received the following two (2) proposals:

Staff reviewed all bid documents for completeness and concluded that FS Contractors, Inc. is the lowest responsive and responsible bidder to perform the construction of this project. FS Contractors, Inc. has satisfactorily completed projects for the City of Covina including the Downtown Trash Enclosure Project – Phase IV, Alleyway Resurfacing Project and the Traffic Calming Improvements Project – Workman Avenue and 2nd Ave Stop Sign Installation.

FISCAL IMPACT:

A funding amount of \$150,000 has been allocated in the City's approved Fiscal Year 2025-2026 Capital Improvement Program Budget for the Trash Enclosure Project – Covina Police Department – Project No. P2604 from Environmental Funds.
