## A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COVINA, CALIFORNIA, AMENDING THE 2024-25 OPERATING BUDGET BY APPROPRIATING \$715,000 FROM THE PUBLIC LIABILITIES FUND – FUND BALANCE FOR USE TOWARDS LEGAL, LIABILITY CLAIMS, AND OTHER RELATED EXPENDITURES

**WHEREAS,** the City of Covina ("City") is a municipal corporation duly organized and existing pursuant to the Constitution and laws of the State of California; and

**WHEREAS,** the reallocation of appropriations may be made by the City Manager, amendments (increases/decreases) to the Budget shall be by approval and Resolution of the City Council; and

**WHEREAS,** in Fiscal Year 2024-25 the City of Covina has experienced a higher than usual amount of expenditures related to public liability claims; and

**WHEREAS,** appropriating this amount will increase Fiscal Year 2024-25 budgeted expenditures in the Public Liability Fund by \$715,000 to ensure adequate appropriations exist to meet the increased needs.
