

RESOLUTION CC 2025-90

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF COVINA,
CALIFORNIA, CERTIFYING AND APPROVING THE SEWER SYSTEM
MANAGEMENT PLAN**

WHEREAS, the City of Covina is a municipal corporation duly organized and existing pursuant to the Constitution and laws of the State of California (“City”); and

WHEREAS, on May 2, 2026, the State Water Resources Control Board (SWRCB) adopted Statewide General Waste Discharge Requirements (2006 GWDR) for publicly owned sanitary sewer systems in order to minimize the occurrence of sanitary sewer spills. Under the 2006 GWDR, the City of Covina was required to develop and implement a Sewer System Management Plan (SSMP), conduct internal audits of the SSMP every two years, and update and resubmit the SSMP to the SWRCB every five years for recertification; and

WHEREAS, on December 6, 2022, the SWRCB adopted new Statewide General Waste Discharge Requirements (2022 GWDR) for publicly owned sanitary sewer systems, which replaced the 2006 GWDR. Under the 2022 GWDR, the City must update the SSMP to comply with the 2022 GWDR provisions by August 2, 2025, continue to update the SSMP every six years thereafter, and conduct internal audits of the SSMP every three years; and

WHEREAS, on January 28, 2025, the City of Covina submitted its Internal Audit of the SSMP under the 2022 GWDR; and

WHEREAS, on July 10, 2025, the City of Covina completed the first update of the SSMP required under the 2022 GWDR. In accordance with the 2022 GWDR, the City Council is required to approve the SSMP prior to its submission to the SWRCB.

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF COVINA,
CALIFORNIA DOES HEREBY RESOLVE AS FOLLOWS:**

SECTION 1. The updated SSMP is hereby approved in accordance with SWRCB Statewide General Waste Discharge Requirements for Sanitary Sewer Systems.

SECTION 2. The Director of Public Works/City Engineer is hereby authorized to submit the updated SSMP to the SWRCB for recertification.

SECTION 3. The City Clerk shall certify to the passage and adoption of this resolution and shall enter the same in the Book of Original Resolutions.
